<p style="text-align: center;">Constitutional Measure No. 1 (House Concurrent Resolution No. 3047, 2011 Session Laws, Chapter 519)</p> <p>This constitutional measure would amend and reenact section 6 of Article IV of the North Dakota Constitution. This measure would prohibit the appointment of a member of the Legislative Assembly to a state office for which the compensation was increased in an amount greater than any general legislative increase provided to full-time state employees during the member's term of office.</p> <p><input type="radio"/> YES - means you approve the measure as summarized above.</p> <p><input type="radio"/> NO - means you reject the measure as summarized above.</p>	<p>This initiated constitutional measure would add a new section to Article I of the North Dakota Constitution stating, "Government may not burden a person's or religious organization's religious liberty. The right to act or refuse to act in a manner motivated by a sincerely held religious belief may not be burdened unless the government proves it has a compelling governmental interest in infringing the specific act or refusal to act and has used the least restrictive means to further that interest. <p style="text-align: center;">Initiated Constitutional Measure No. 2</p> <p>This initiated constitutional measure would amend sections 1, 4, 14, 15, and 16 of Article X of the North Dakota Constitution and repeal sections 5, 6, 7, 9, and 10 of that same article, eliminating property taxes, poll taxes, and acreage taxes, effective January 1, 2012.
