<p>SECTION 1. A new section to chapter 36-01 of the North Dakota Century Code is created and enacted as follows:</p> <p style="padding-left: 40px;">Fee killing of certain captive game animals prohibited – Penalty – Exception. A person is guilty of a class A misdemeanor if the person obtains fees or other remuneration from another person for the killing or attempted killing of privately-owned big game species or exotic mammals confined in or released from any man-made enclosure designed to prevent escape. This section does not apply to the actions of a government employee or agent to control an animal population, to prevent or control diseases, or when government action is otherwise required or authorized by law.</p> <p>SECTION 2. EFFECTIVE DATE.
