### MEASURES BALLOT

#### Constitutional Measure No. 1 (HOUSE CONCURRENT RESOLUTION NO. 3034, 2013 SESSION LAWS, CH. 518)

This constitutional measure would amend and reenact sections 5, 6, and 7 of Article III of the North Dakota Constitution by changing the filing deadline for the submission of initiated measure petitions from ninety days to one hundred twenty days before a statewide election, and by providing that any challenges regarding measure petitions must be filed with the Supreme Court no later than seventy-five days before the election.

#### County Measure No. 2 .5% SALES AND USE TAX

Shall the Morton County Commission be authorized to implement and collect a one half of one percent (.5%) sales and use tax outlined in Ordinance #2014-1, for the purpose of funding the construction of a Joint Detention Center with Burleigh County and a remodel of existing detention space?  
If approved, this sales tax shall take effect on October 1, 2014, and shall terminate upon final payment of construction bonds for the proposed project.
