County Measure No. 1

Shall the Board of County Commissioners of Pembina County, North Dakota, be authorized to levy an additional five (5) mills, for the maintenance and repair of roads and bridges within the County, on all taxable property in Pembina County, pursuant to NDCC 57-15-06.3.
