MEASURES BALLOT

County Measure No. 1

Should the current emergency services communication (9-1-1) fee not to exceed \$1.00 per month per "communication connection" (telephone access line, wireless access line, unique voice over internet protocol service connection, or functional equivalent uniquely identifiable by a number, internet address, or other designation) for the operation and maintenance of the 9-1-1 emergency services communications system be increased to a maximum (not to exceed) \$1.50 per month?

Voter approval would allow a fee, not to exceed \$1.50 per month per "communication connection" to become effective January 1, 2015 with the revenue dedicated to maintaining and operating the emergency services communication (9-1-1) system as required by State law.

Constitutional Measure No. 1
(HOUSE CONCURRENT RESOLUTION NO. 3034, 2013 SESSION LAWS, CH. 518)

This constitutional measure would amend and reenact sections 5, 6, and 7 of Article III of the North Dakota Constitution by changing the filing deadline for the submission of initiated measure petitions from ninety days to one hundred twenty days before a statewide election, and by providing that any challenges regarding measure petitions must be filed with the Supreme Court no later than seventy-five days before the election.
