



VOTING WHILE HOMELESS IN NORTH DAKOTA

**IF YOU ARE A U.S. CITIZEN AND
LIVE IN NORTH DAKOTA
YOU HAVE THE RIGHT TO VOTE!**

Anyone who has lived in North Dakota for 30 days prior to an election can vote.

North Dakota does not require voter registration, but you do need to have a form of identification that can be used for voting. Below are options you have to vote, either absentee or at the polls, if you are homeless.

VOTER IDENTIFICATION

You need one of the following forms of ID to vote:

- North Dakota Driver's License
- North Dakota Non-Driver ID
- Tribal ID or Tribal Letter
- Long Term Care Certificate

Identification and tribal government IDs or documents should have your **name, residential address, and date of birth.**

GETTING VOTER IDENTIFICATION

If you are homeless and do not have one of the North Dakota forms of ID listed above, you can obtain a North Dakota Driver's License or Non-Driver ID from the North Dakota Department of Transportation. You will need one (1) of the following to obtain a North Dakota Driver's License:

- Birth Certificate
- Vaid U.S. Passport

A license you received from a different state cannot be used to obtain a North Dakota Driver's License or Non-Driver ID.

I HAVE A NORTH DAKOTA ID THAT ISN'T UPDATED

If you are unable to update your North Dakota ID, you still have the right to vote as a North Dakota resident if you are a U.S. citizen.

PROVIDE SUPPLEMENTAL INFORMATION

You can **bring your non-updated identification along with supplemental information** that includes your updated address to the polling location on Election Day. **Supplemental documentation** that will be accepted includes:

- Current bank statement
- Paycheck or paystub
- Check or document issued by a federal, state, tribal, or local government
- Relief Agency or Shelter Certification
- A letter from the the property owner or renter you are staying with stating that you are living at their address



I DO NOT HAVE A NORTH DAKOTA ID

You may not use identification from another state to vote in North Dakota.

OBTAIN A NORTH DAKOTA ID

You can **get a Non-Driver ID for FREE** for voting purposes from the **North Dakota Department of Transportation**. You will need to present proof of both citizenship and residency:

- **Proof of Citizenship Options**
 - Birth Certificate
 - Valid U.S. Passport
- **Proof of Residency Options**
 - Current bank statement
 - Paycheck or paystub
 - Check or document issued by a federal, state, tribal, or local government
 - Relief Agency or Shelter Certification
 - A letter from the the property owner or renter you are staying with stating that you are living at their address



I DO NOT HAVE AN UPDATED ID ON ELECTION DAY

YOU CAN STILL VOTE A SET-ASIDE BALLOT

If you do not get your identification updated or are unable to obtain identification, you can vote by **set-aside ballot** during early vote or on Election Day. This means you cast your ballot and it is placed in an envelope to be presented to the County Canvassing Board for review.

- **Within 13 days** after the election, you must **update or present** your **driver's license, non-driver ID, Tribal ID or documentation, or Long Term Care Certificate** before the County Canvassing Board meets.
- You may submit your identification to the **county auditor, in person or electronically**, and your ballot will be counted. You will be provided information about this process when voting a set-aside ballot.
